Course Overview

This interdisciplinary course explores leadership as a historically situated and culturally constructed phenomenon. Using Singapore as a case study, students will examine how leadership has evolved over time in response to shifting political, economic, and social forces.

Through historical and comparative analysis, the course investigates how leaders in Singapore have navigated complex issues of governance, national identity, and multiculturalism from the colonial era to the present. Students will explore key historical events, institutional developments, and policy shifts that have influenced the country's leadership style and cultural understanding of leadership.

Drawing from history, sociology, political theory, and cultural studies, students will be shown various dimensions of leadership. Field visits to local institutions and cultural sites will offer practical insight into how historical narratives shape contemporary leadership. Guest lectures from scholars and practitioners will further illuminate the interplay between history, leadership, and globalization in the Singaporean context.
